
अधिसूचना

राज्यपाल, न्यूनतम मजदूरी अधिनियम, 1948 (अधिनियम संख्या 11 सन् 1948) (उत्तराखण्ड में यथा प्रवृत्त) की धारा 22 ग (उत्तर प्रदेश संशोधन) सपिठत साधारण खण्ड अधिनियम, 1897 (अधिनियम संख्या 10 सन् 1897) की धारा 21 द्वारा प्रदत्त शक्तियों का प्रयोग करके इस संदर्भ में पूर्व में जारी की गई अधिसूचना संख्या 1985/औ॰वि॰/2001–123(श्रम)/2001, दिनांक 23.07.2001 को विखण्डित करते हुए नीचे दी गयी अनुसूची के स्तम्भ–2 में उल्लिखित 'अधिकारियों' को अनुसूची के स्तम्भ–3 में उल्लिखित क्षेत्रों के लिये उक्त अधिनियम के अधीन निम्न शर्तों के साथ अपराधों का उपशमन करने हेतु अधिकृत करते हैं—

- (1) कोई भी अपराध केवल चेतावनी तथा भर्त्सना देकर उपशमन नहीं किया जायेगा।
- (2) किसी अपराध के लिए यदि न्यायालय में अभियोजन संस्थित नहीं किया गया है तो अपराध का "उपशमन" अधिनियम में इस हेतु निर्धारित सीमा के भीतर ही किया जाएगा। यदि न्यायालय में अभियोजन लंबित है तो 'उपशमन' अभियोजन साक्ष्य की समाप्ति से पूर्व ही किया जा जायेगा।

Notification

In exercise of the powers conferred by section 22 C (Uttar Pradesh Amendment) of the Minimum Wages Act, 1948 (Act No. 11 of 1948) (as applicable of the State of Uttarakhand) read with section 21 of General Clauses Act. 1897 (Act No. 10 of 1897), the Governor is pleased to authorise the officer mentioned in column 2 in the Schedule given below for the areas mentioned in column 3 for composition of offences under the said Act under following conditions rescinding the previous notification No. 1985/I.D/2001-123 (labour)/2001, dated 23-07-2001 issued regarding it.

- 1- No offences shall be compounded only by giving warning and admonition.
- 2- If any prosecution has not been instituted for any offence in the court, then the offence shall be compounded within the prescribed limit for this in the Act. If the prosecution is pending in the court, then it shall be compounded only before the completion of the evidence of prosecution.
